### WestCare Kentucky – Hal Rogers Appalachian Recovery Center Men's Residential Program

**Purpose** 

WestCare Kentucky's Men's Residential Program provides intensive alcohol and other drug abuse treatment services for adult males residing at the WestCare Kentucky Hal Rogers Appalachian Recovery Center. Men's Long-Term Residential services are provided in a male-only facility, and the clinical curriculum is designed to better serve the needs of men. The Men's Long-Term Residential Program allows for a stay in treatment a minimum of 90 days. We are also licensed for providing DUI assessments, education and treatment.

**Services and Scope** 

This 88 bed program services include specialized alcohol and drug curricula for adult male participants in a modified therapeutic community model of care. Services in the Men's Residential Program include: individual and group counseling; vocational skills development activities, including emphasis on technical skills; alcohol and drug education classes; relapse prevention; introduction to community-based support services; optional weekly onsite chapel services and community-based 12-Step meetings; family and significant other educational/support services; and HIV/AIDS education, parenting classes, and counseling. The focus and intensity of treatment is modified to accommodate the realistic/practical treatment needs of males as they begin admitting and embracing their own need for continuing recovery. The process of treatment in this program is one of discovery and sets a firm foundation to allow men to empower themselves and become responsible for their own recovery.

**Funding Source(s)** 

WestCare Kentucky's Men's Residential Program is partially funded by Operation UNITE, Kentucky Department of Corrections, United States District Court Federal Probation, self pay and Insurance. Assessment of a participant's ability to pay for a portion, or all, of the cost of treatment is determined on a case-by-case basis. Service is never refused due to a participant's inability to pay; however, some programs may have waiting lists.

# WestCare Kentucky – Pike County Community Involvement Center (CIC)/Outpatient Program

**Purpose** 

**Services and Scope** 

**Funding Source(s)** 

WestCare Kentucky's Community Involvement Center (CIC)/Outpatient Program provides licensed alcohol and other drug abuse outpatient treatment services for adults who reside within Pike and surrounding counties. The Outpatient Program serves the needs of adults who require substance abuse treatment while working and living in the community, but who do not require the more intensive services provided in a residential program.

The WestCare CIC/Outpatient Program services include: individual and group counseling alcohol and drug education classes; a relapse prevention curriculum; an introduction to community-based support services; orientation to community-based, self-help meetings; family and significant other education/support services; educational and vocational rehabilitation assistance; community referrals; Drug testing and Second Chance Act providing re –entry services for offenders and ex-offerers in the Pike County Detention Center. Driving Under the Influence assessments are available. A determination of the intensity of treatment needed is made at initial assessment and is modified to accommodate the realistic/practical treatment needs of clients as they progress within the program. WestCare Kentucky was awarded a second chance act mentoring of ex-offenders grant from the bureau of justice assistance. This grant will offer mentoring to 80 men and women over the next two years.

WestCare Kentucky's CIC/Outpatient Program is partially funded by the Bureau of Justice Assistance, self pay and community donations. Assessment of a participant's ability to pay for a portion, or all, of the cost of treatment is determined on a case-by-case basis. Service is never refused due to a participant's inability to pay; however, some programs may have waiting lists.

**Services and Scope** 

The 68 bed Recovery Program includes individual and group counseling, vocational skills training, alcohol and drug education classes, relapse prevention, and introduction to 12-Step meetings. The focus and intensity of treatment is modified to accommodate the realistic/practical treatment needs of individuals as they begin embracing their own need for continued recovery. The process for treatment in the program is one of discovery and sets a firm foundation to allow the individuals to empower themselves and become productive members of society and their community.

Once the individual completes treatment and is released from jail, she is eligible to enter residential services in the community to continue his treatment and assist with re-integration back into society. PCDC is licensed under the Commonwealth of Kentucky as an Alcohol and Other Drug Entity Intensive Outpatient Treatment Program

**Services and Scope** 

The 16 bed Recovery Program includes gender specific individual and group counseling, vocational skills training, alcohol and drug education classes, relapse prevention, and introduction to 12-Step meetings. The focus and intensity of treatment is modified to accommodate the realistic/practical treatment needs of individuals as they begin embracing their own need for continued recovery. The process for treatment in the program is one of discovery and sets a firm foundation to allow the individuals to empower themselves and become productive members of society and their community. A re-entry coordinator also works with the women in the program to provide them the additional tools for success.

**Purpose** 

becoming or are homeless. Services are for both adult males, females and families residing in Pike and surrounding counties. On site, residents receive assistance with cognitive skills, financial literacy, adult education, life skills, employment skills and drug treatment.

**Services and Scope** 

The shelter staff provides individual case assessments and development of services/treatment plans to assist individuals in their transition and adjustment back in to the community. The shelter provides lodging, meals, individual counseling, group counseling, substance abuse counseling, life skills, parenting skills, money management, employment readiness and development, literacy, case management, transition to independent living and aftercare services. The maximum length of stay is 90 days; however, an extension may be granted on a case-by-case basis.

WestCare Kentucky's Emergency Homeless Shelter, located in Pikeville Kentucky, provides housing, substance abuse services and independent living skills for individuals and/or families who are at risk of

# WestCare Kentucky – Estill County Transitional Living Apartments

**Purpose** 

Community Involvement Center which is licensed under the Commonwealth of Kentucky as an Alcohol and Other Drug Entity Outpatient Treatment Facility. The Apartments will give residents a safe and sober environment in which to reside, with support close by, so that they can begin the transition into permanent housing, while maintaining their recovery.

Estill County Transitional Living Apartments is located on the second floor of the Estill County

**Services and Scope** 

The Apartments consist of 4 units of transitional living housing to occupy the second floor of the existing Community Involvement Center (CIC) in Irvine, KY. These units will contain 1 or 2 bedrooms, a living/dining area, kitchen and bathroom. Families will be given preference for the 2 bedroom units, but in absence of a family occupant, "roommates" can be assigned, especially in the 2 bedroom units. The project will target clients experiencing substance abuse and domestic violence problems. There is a small laundry room which include 2 coin operated washers and dryers. All utilities are included in the rent.
