Purpose

WestCare Kentucky's Health Resources and Services Administration (HRSA) funded Network Planning Grant is based in Tennessee. The primary goal of this program is to establish a network of health care providers, mental health providers, and law enforcement officials in an attempt to integrate mental health and substance abuse treatment with primary care. The Hancock County Rural Health Network has been created, and is actively completing a community needs assessment, an HIT readiness assessment, an economic impact analysis, and a program mapping project for the state of Tennessee and the border counties of southwest Virginia.

Services and Scope

Although the Hancock County Rural Health Network is not currently providing mental health or substance abuse treatment services, we do provide resource lists and educational literature to any resident who asks for assistance. We hope to apply for an implementation grant in order to provide services in the future.

Funding Source(s)

The Network Planning Grant in Tennessee is funded by the HRSA Office of Rural Health Policy. This grant will last for the duration of one year.
