Purpose

The primary goal of the Intensive Treatment Unit (ITU) located at the Wyoming Medium Correctional Institution (WMCI) in Torrington WY, is to reduce the incidence of substance abuse relapse and recidivism among residents. In addition the ITU promotes pro-social behavior that will enable the residents to exhibit satisfactory conduct within the facility leading to a successful integration back into the community. The program is designed to provide long-term intensive alcohol and other drug abuse treatment services for incarcerated men.

Services and Scope

The 144 bed in-prison residential Therapeutic Community, is a behavioral modification program with a focus on addressing criminal thinking errors and developing pro social behaviors. Therapeutic Community program provides gender-specific behavioral modification recovery services. The WMCI ITU includes individual and group counseling, cognitive skills, cognitive restructuring, social skills, interpersonal problem solving, anger management, trauma recovery, life-skills, parenting, alcohol and drug education classes, relapse prevention, and an introduction to (12) step meetings.

Purpose

The primary goal of the Intensive Outpatient Program (IOP), located at the Wyoming Medium Correctional Institution (WMCI) in Torrington WY, is to reduce the incidence of substance abuse relapse and recidivism among the general male inmate population and increase pro-social skills which lead to successful community reintegration. WestCare's Wyoming WMCI IOP provides up to fifteen hours per week of in-prison intensive outpatient substance abuse education and treatment.

Services and Scope

The Intensive Outpatient program (IOP) at Wyoming Medium Correctional Institution will service 64 male offenders with a 4 month length of stay. The IOP will be designed to provide a cognitive behavioral intervention and intensive substance abuse treatment to parolees with technical violations. The IOP will: Provide each intensive outpatient participant a minimum of 15 hours programming per week. Provide each participant with clinical services including group counseling and individual counseling. Incorporate Cognitive Behavioral Training and Relapse Prevention Training. Provide curriculum-based substance abuse education and skills training using evidence based programs and materials. Provide case managed transition services and referrals.
